 - i. Hancock Center HEB expansion.
 - c. The Flea Report
 - i. Recruitment of a new editor for the Flea as JPM is resigning. We need someone with some experience in copy editing. The Flea is our notification avenue to tell residents what is happening. We also need to step up our social media presence.
 - d. Jim Walker reported UBC Update: has not met.
- e. Jules Vieau reported on the ANC Update: regrouping, re-examining non-profit status.

 - a. IH-35 / NCINC3 planning

- i. Phase 2 of TxDoT scoping period feedback will be extended. We will ask residents to comment, volume matters. City Council Member Tovo is supportive of neighborhood-centric zones on the frontage road. Jim W. will refresh our letter to speak to the second phase.
- ii. Frontage road principles: start with a vision, then think about how to get there. Limit incursion into the neighborhood.
- b. Cherrywood Green: Girard K solicited deliveries of large limbs to the area to stop erosion.
