Summer in the Neighborhood

This summer heat is as heavy as I can remember ... I hope everyone is in a position and has resources to manage their preparation and exposure! We'll be in-person for our next General Meeting on August 16 at Cherrywood Center (aka Servant Church, aka Asbury Methodist) at the corner of Cherrywood Rd and E. 38 1/2 St. We look forward to hosting our state Senator Sarah Eckhardt's office to recap the Legislative session (it's still going!) and chat with us about I-35 issues (that's still going too!). We'll talk quite a bit about I-35 and the most recent news about possibilities of an expanded cap in our section.

But first, a look back. The May 17 General Meeting had a very sparse turnout at Cherrywood Center. We learned from current pastor Liz Spence about the evolution of Cherrywood Center toward a more community-oriented venue, (check out www.cherrywoodcenter. com). We continued to discuss the I-35 Capital Express project as TxDOT's current design winds through the Draft Environmental Impact Statement process (see last several issues of the Flea newsletter). We also continued open discussion about the land history of our neighborhood and the pros/cons of the

neighborhood association filing to become a formal non-profit organization.

We also discussed how to encourage more Accessory Dwelling Units (ADUs) in meaningful to you for any reason, drop an email to chair@cherrywood.org.

In June, the Steering Committee heard from Michelle Marx, Division Manager for the Our Future 35 – Austin's Cap and Stitch Program about the City's efforts to determine future uses and to "stretch" existing cap and stitch opportunities suggested by TxDOT in their current design. We had a lively Q&A about the various rumors of major design revisions all along the corridor, including our long-standing pursuit of a 'North Central Deck' in the Cherrywood/Hancock section, the various constraints guiding staff considerations, the timeline of the process and what kind of financing strategies the City was considering.

Then, in mid-July came news from City of Austin elected officials and TxDOT regarding late-breaking opportunities for larger caps/decks around the East 38 ½ St. bridge. The Steering Committee held a special meeting on Tue, July 18 to discuss and approve a letter expressing excitement for the direction of these new ideas but also noting how the new options could be further improved. The Steering Committee is hyper-conscious that this is a multi-generational

expect to have to advocate consistently and strongly for every improvement.

We'll discuss I-35 even further at our Aug. 16 General Meeting.

Moving on ... We're fast approaching the annual cycle of seeking new residents (homeowners and renters and business owners) to serve on the Steering Committee. The

Cherrywooders Welcome New Coffee Shops, Food Trucks Around Neighborhood

Cherrywooders, already accustomed to excellent coffee shops by way of Cherrywood Coffee House and Thunderbird, now have three more ways to get their buzz on. Opened in February, Progress Coffee + Bar is serving up hot and cold caffeine beverages made from small batch coffees roasted on site. The storefront also serves beer and cocktails, including the aptly named Cherrywood smoked Old Fashioned. Located at 3421 I-35 North, it's at the corner of Frontage Road and Concordia Ave. In addition, food trucks Pueblo Viejo and Li'L Nonna's are parked out back for those looking to enjoy authentic Mexican street food from the former and madefrom-scratch vegan pizza from the latter. Not to be outdone, Civil Goat Coffee opened up their third location in March at 2610 Manor Road, the former location of Vida Pura (and before that, In.gredients). This specialty coffee roaster also offers several food options for breakfast and lunch, including specialty toasts, acai bowls, and more. Last but not least, Fleet Coffee opened their second location in July. Located at 2806 Manor Road, the trailer is serving coffee beverages with beans roasted by Parlor Coffee and Sweet Bloom Coffee Roasters, as well as teas from Spirt Tea. Sharing the space is La Santa Barbacha, a food truck serving homemade barbacoa, specialty tacos, and refreshing agua frescas. With these welcome additions, Cherrywooders may continue to boast having one of the best walkability scores in Austin.

Coyotes Among Us


Coyotes are known to kill pets in Austin. Overnight in Cherrywood recently, both a cat in a frontyard and a small dog inside its fenced yard were killed. Vigilance on behalf of your pets during outside activity is life-saving. Because we share greenspace and dense habitat supporting wildlife including coyotes, please be aware of the need to proactively protect your pets.


Typical coyote activity occurs from dusk to dawn, though they can be seen during daylight as well. If you see a coyote during the day, then try to haze it with noisemaking: shouting, clapping, and throwing non-edible objects in a coyote's direction such as rocks or tennis balls. Hazing strengthens coyotes' natural wariness without harming them while associating negative consequences with their proximity to humans and pets.

Don't haze a coyote at night, or if it is with or near offspring, sick, injured or cornered – give it the space to leave.

Limit attractants on your property such as food sources like pet food and bird seed; fruit or nuts on the ground can also be alluring to a coyote; secure garbage and compost bins; keep pets securely on a leash (avoid retractable), accompany pets outside, and bring pets indoors overnight, especially cats. Austin's coyote management policy uses science to manage coyote-human interactions. Austin does not remove or relocate native wildlife.

Report sightings, encounters, incidents or concerning behavior to 311, which is monitored by Wildlife Officers who can help mitigate issues and provide further information:
